**ASSIGNMENT BACK OF TRADEMARKS**

WHEREAS The Toronto-Dominion Bank (the "Bank"), a Canadian bank located at 201 Portage Avenue at Main Street, Winnipeg, Manitoba, Canada R3C 2T2, is now indicated to be the owner of the following marks (the "Trade Marks") which are registered or are pending registration in the official records of the United States Patent and Trademark Office by reason of a certain Collateral Assignment of Trademarks made as of July 7, 1998 (the "Collateral Assignment") recorded at Reel 1848, Frame Nos. 0432-0440 in the Assignment Branch of the United States Patent and Trademark Office:

WHEREAS the Collateral Assignment was taken by the Bank on its own behalf and its capacity as agent for certain other financial institutions (the Bank and those other financial institutions referred to hereinafter collectively as the "Lenders");

WHEREAS Palliser Furniture Ltd. ("Palliser"), a Canadian corporation located at 55 Furniture Park, Winnipeg, Manitoba, Canada R3G 1B9, is and at all times has been the title owner of the Trade Marks and it was intended only that the Bank, as agent for the Lenders, have a security interest therein but not ownership thereof;

WHEREAS Palliser and the Bank on behalf of the Lenders are desirous of rectifying the registration of ownership of the Trade Marks in the official records of the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Bank on behalf of the Lenders does hereby reassign unto Palliser all right, title and interest in and to each of the Trade Marks, as well as any future trademarks as set out in paragraph 7 of the Collateral Assignment, together with the goodwill of the business symbolized by each of the marks, and the above identified registrations and registration applications therefor. Provided, however, that such reassignment shall not constitute an assignment or release of any security interest which the Bank holds on behalf of the Lenders.

The Bank, on behalf of the Lenders, hereby releases Palliser from all the warranties and representations and obligations it has, and has given, as set forth in paragraph 3 subparagraphs (a) to (e), and paragraphs 4, 6, 7 and 8 of the Collateral Assignment. Provided, however, that such release shall not be deemed to release Palliser from any

similar representations, warranties or obligations contained in any other agreement or instrument to which it is a party.
