ARTICLES OF AMENDMENT  
OF  
TACOMA ELECTRIC SUPPLY, INC.

Pursuant to the provisions of RCW 23B.10.060 of the Washington Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment:

ARTICLE I

The name of the corporation is TACOMA ELECTRIC SUPPLY, INC., a Washington corporation ("Corporation").

ARTICLE II

The Corporation's articles are amended for the sole purpose of changing the name of the Corporation to CONNECTICUT ELECTRIC & SWITCH MFG. CO.

ARTICLE III

The amendment of the Corporation's articles was adopted by the Board of Directors on October 11, 2000 without shareholder action in accordance with RCW 23B.10.020.
