ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT

THIS ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT (this "Assignment") is dated as of August 27, 2004 by NORTH FORK BANK, a New York bank ("Assignor"), having an address at 275 Broadhollow Road, Melville, New York 11747 to LAKELAND BANK, a New Jersey bank ("Assignee"), having an address at 250 Oak Ridge Road, Oak Ridge, New Jersey 07438.

This Assignment is being executed and delivered pursuant to a Loan Purchase and Sale Agreement dated as of August 27, 2004 (the "Purchase Agreement"), between Assignor and Assignee that relates to the sale of the loan made pursuant to (i) that certain Loan and Security Agreement dated as of August 6, 2003 between Media Sciences International, Inc, Media Sciences, Inc. and Cadapult Graphic Systems, Inc. (the "Borrowers") and The Trust Company of New Jersey, predecessor in interest to the Assignor, as amended by the First Amendment to Loan and Security Agreement dated June 11, 2004 between the Borrowers and the Assignor (the "Loan"). The Purchase Agreement provides for, among other things, the sale and transfer by Assignor to Assignee of the Loan together with all documents relating to the Loan, including without limitation, that certain Trademark Security Agreement dated as of August 6, 2003 between Media Sciences International, Inc. and Assignor (the "Trademark Security Agreement").

For good and valuable consideration, the adequacy and receipt of which are hereby acknowledged by Assignor, and for the purpose of effecting such sale, conveyance and transfer pursuant to the provisions of the Purchase Agreement, Assignor agrees as follows:

1. Assignment by Assignor. Assignor hereby sells, transfers and conveys to Assignee, its successors and assigns, all of Assignor's right, title and interest in and to the Trademark Security Agreement. This Assignment is made without recourse, and without representation or warranty except as expressly set forth in the Purchase Agreement.

2. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of New Jersey.
