I, Rebecca Borden, being duly sworn, depose and state:

1. I am an Assistant Secretary of Infinity Technical Services, Inc. ("Infinity Tech"). This corporation was incorporated on September 30, 1999, according to the laws of the State of Delaware, United States of America.
2. As an Assistant Secretary of Infinity Tech, I am fully familiar with the trademarks it owns.
3. This Affidavit is submitted in support of Infinity Tech's correction of the incorrect Name Change recordal of the federal mark Registration No. 1.832.921 for the mark TRUE TO THE MUSIC (the "Mark") to Infinity Technical Services, Inc. on March 7, 2001, which is recorded at Reel/Frame number 2260/0374.
4. Portland Radio Inc. registered the Mark on April 26, 1994.
5. Portland Radio Inc. assigned the Mark to American Radio Systems Corporation on May 27, 1998. The assignment is correctly recorded at Reel/Frame number 2043/0231.
6. American Radio Systems Corporation assigned the Mark to CBS Radio Inc. on June 4, 1998. The assignment is correctly recorded at Reel/Frame number 2044/0581.
7. CBS Radio Inc. changed its name to Infinity Radio Inc. on August 29, 2000 at 9:01AM. The name change is correctly recorded at Reel/Frame number 2179/0113. ("Transaction A")
8. Earlier on August 29, 2000, at 9:00AM, another corporation named Infinity Radio Inc., which bore no relationship to either CBS Radio Inc. or Infinity Radio Inc. that are mentioned in the previous paragraph, changed its name to Infinity Technical Services, Inc. ("Transaction B").

- 9. From August 29, 2000, the Mark should have remained recorded as owned by Infinity Radio Inc. in accordance with Transaction A that is described in Paragraph 7. However, Infinity Radio Inc. inadvertently submitted a request to record its change of name to Infinity Technical Services, Inc. on March 7, 2001 by erroneously submitting the changes related to Transaction B as described in Paragraph 8. This change of name was erroneously recorded at Reel/Frame 2260/0374. The true chain of title of the Mark should not be altered by this name change.
- 10. Infinity Tech hereby confirms that Infinity Radio Inc. has been and continues to be the correct owner of Registration No. 1.832.921 for the mark TRUE TO THE MUSIC mark, pursuant to the change of name dated August 29, 2000 at 9:01AM. The name change of the owner from Infinity Radio Inc. to Infinity Technical Services, Inc. should not have been submitted for recordal.
