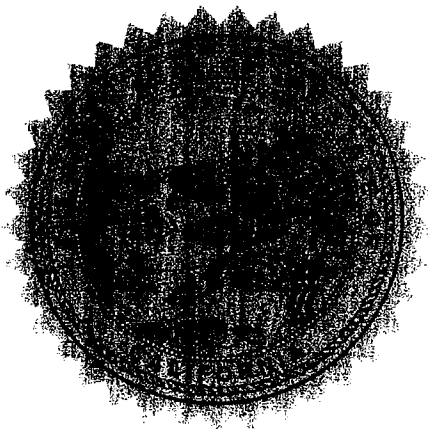



ONE: The name of this Corporation is

4. The foregoing amendment has been approved by the required vote of the shareholders in accordance with Sections 902 of the California Corporations Code. The corporation has one class of shares, Common Stock. Each outstanding share of Common Stock is entitled to one vote. The total number of shares of Common Stock issued and outstanding is 2,000,000. The number of shares voting in favor of the amendment exceeded the vote required, in that the amendment was approved by the affirmative vote in excess of a majority of the outstanding shares.
