ASSIGNMENT OF TRADE MARK

THIS AGREEMENT is made the 9th day of March 2003.

BETWEEN:

(1) **Dr. ROY CLAMPITT** (hereinafter referred to as "the Assignor") of Egypt, Playing Close, Charlbury, Oxfordshire, OX7 3QP, and

(A) the Assignor is proprietor and beneficial owner of the trade mark HYDRICE and the application No. 76357407 in classes 1,4 and 7 filed 11 January 2002 for registration thereof in United States of America (the "Trade Mark")

(B) the Assignor and the Assignee have agreed that the Trade Mark is to be assigned to the assignee.

NOW THIS ASSIGNMENT WITNESSETH as follows:

1. The Assignor hereby assigns to the Assignee all its property, rights, title and interest in and to the Trade Mark including the goodwill of the business symbolized by the Trade Mark and the registration for the territory of the United States of America and the right to sue for all infringements and threatened infringements of the Trade Mark whether prior to, on or after the date of this Assignment to the intent that the Assignee shall be the owner of the Trade Mark.


2. The Assignee shall pay the cost of the preparation and recording of this Assignment in the United States Patent and Trademark Office.


3. The Assignor agrees that it will at the request and cost of the Assignee render all such documents and things as may from time to time be necessary for giving effect to this Assignment and for the registration of the Assignee as owner of the Trade Mark and the Assignor hereby gives consent to the Assignee to take solely in its name all necessary procedures for such recording of this Assignment.




