ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT is hereby entered into this 22 day of May, 2001, by and between L'OVEN, INC. (the "Assignor"), a Missouri corporation, and LA BONNE BOUCHEE DE ST. LOUIS, INC. (the "Assignee"), a Missouri corporation.

WITNESSETH:

WHEREAS, L'OVEN, INC. is the owner of a Federal Service Mark, Registration No. 1,243,279, registered June 21, 1983 and a Federal Trademark Service Mark, Registration No. 1,232,939, registered March 29, 1983, each relating to a unique stylized mark for the phrase La Bonne Bouchee; and

WHEREAS, L'OVEN, INC. registered its Service-Mark for "La Bonne Bouchee & Design" with the Office of the Secretary of State, State of Kansas on January 16, 1992; and for the Service Mark "LA BONNE BOUCHEE", with the Office of the Secretary of State, State of Missouri, on December 17, 1981, and renewed on August 17, 1991; and

WHEREAS, L'OVEN, INC. has ceased its active conduct of business and desires to transfer all rights, interest and title to said registered Service and Trademarks and their use to the Assignee.;

NOW, THEREFORE, the parties hereto do hereby agree as follows; to wit:

1. For the sum of one dollar and other valuable consideration, Assignor does hereby sell, assign and convey all of its right, title and interest of whatever nature in the aforescribed Service Marks and Trademark Service Mark, (hereinafter collectively referred to as the "Marks") to the Assignee, effective as of the date of this Assignment Agreement.
2. The Assignee agrees to timely and promptly file in writing all notice necessary to effectuate this transfer and assignment of rights to said Marks and further agrees

to hold Assignor harmless from any claim or claims arising out of the Assignees use of the Marks, from and after the date of this Assignment Agreement.
