NOW, THEREFORE, the parties agree as follows:


Assignor hereby irrevocably assigns to Assignee all of Assignor's entire worldwide right, title and interest in and to the trademark "HET," including United States Trademark Registration No. 589,148 for the mark "HET (stylized)," and those Registrations shown on the attached Exhibit A and the goodwill associated with such trademark (the foregoing collectively, the "*Trademark*"), and the right to bring suit and recover for damages and other remedies in respect of any infringement of the Trademark which may have occurred prior to the date of this Assignment for a purchase price of one United States Dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged.

The foregoing assignment is made without any representation or warranty of any kind. Assignor hereby disclaims, and Assignee hereby waives, all warranties whatsoever, express or implied, including without limitation warranties of title, non-infringement, registerability or registration status, renewability and otherwise, in connection with the Trademark or this Assignment. Assignor agrees to execute all further documents reasonably necessary in the future to effect this Assignment and the recordation in any of the relevant countries.

This Assignment may be executed in counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument.
