## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "AGREEMENT"), is made as of the 30<sup>th</sup> day of July, 2004, by and between W. R. Grace & Co.-Conn., a Connecticut Corporation ("Assignor") located at 7500 Grace Drive, Columbia, Maryland 21044, USA and The Separations Group, a California Corporation ("Assignee") located at 7500 Grace Drive, Columbia, Maryland 21044, USA.

### WITNESSETH:

**WHEREAS**, Assignor owns all right, title and interest to the trademarks identified in the attached Schedule A (collectively, the "Separations Trademarks").

**WHEREAS**, Assignee is desirous of acquiring all rights in the Separations Trademarks, together with the goodwill of the business with which the Separations Trademarks are used, and which are symbolized by said Separations Trademarks and the right to recover for past infringement of said Separations Trademarks;

**NOW, THEREFORE**, in consideration of the promises, covenants and agreements contained herein and intending to be legally bound, Assignee and Assignor agree as follows:

1. Assignor hereby assigns, transfers and delivers unto the Assignee, its successors, assigns or other legal representatives, Assignor's entire right, title and interest in and to the Separations Trademarks, the right to recover for past infringement of said Separations Trademarks, and the goodwill and the portion of the business acquired by and associated with the Separations Trademarks.
2. Assignee hereby accepts the assignment, transfer and delivery of the Separations Trademarks.
3. This Agreement may be signed in counterparts, each of which shall constitute an original and which together shall constitute one and the same instrument.
