THIS RELEASE OF SECURITY INTERESTS ("Agreement") is made and entered into as of the date set forth above, by GMAC Commercial Finance Development Limited, GMAC Commercial Finance plc, and GMAC Commercial Finance LLC (the "Secured Parties").

WHEREAS, on July 8, 1998, Corestaff Services, Inc. (the "Borrower") and BNY Financial Corporation (the "Lender") entered into a certain Revolving Credit and Security Agreement (the "Credit Agreement");

WHEREAS, Corporate Services Group Holdings, Inc. (the "Pledgor"), along with other related entities, is a guarantor of the Borrower's obligations under the Credit Agreement, as amended;

WHEREAS, pursuant to the Credit Agreement and related agreements, the Secured Parties have a continuing security interest in, and continuing lien upon certain collateral, including without limitation all of Pledgor's right, title and interest in and to the trademarks, trademark applications and service marks attached on Schedule A hereto (collectively, the "Trademarks");

WHEREAS, subsequent to the date of the Credit Agreement, but prior to the date of this Agreement, the Lender changed its name to GMAC Commercial Credit LLC, which changed its name to GMAC Commercial Finance LLC, BNY Financial Limited changed its name to GMAC Commercial Credit Development Limited, which changed its name to GMAC Commercial Finance Development Limited, and BNY International Limited changed its name to GMAC Commercial Credit Limited, which changed its name to GMAC Commercial Finance plc; and


WHEREAS, the Secured Parties wish to release the security interests in the Trademarks and to record said release with the United States Patent and Trademark Office.




