ASSIGNMENT AND ACKNOWLEDGEMENT AGREEMENT

This Assignment and Acknowledgement Agreement (the "Agreement") is entered into this the 26th day of April, 2004 by and between BBA GROUP PLC., a public limited company organized under the laws of England and Wales, having a principal place of business at 20 Balderton Street, London, England W1K 6TL (hereinafter, "ASSIGNOR") and SCANDURA ACQUISITION CORP. (n/k/a Fenner Dunlop (Charlotte), Inc.), a Delaware corporation with its principal place of business at 8720 Red Oak Boulevard, Suite 510, Charlotte, North Carolina 28217 (hereinafter, "ASSIGNEE").

WHEREAS, ASSIGNOR is the sole and exclusive owner of all rights, title and interest in and to the Trademarks, Trademark Registrations and applications listed on **Exhibit A** attached hereto (hereinafter the "Trademarks");

WHEREAS, pursuant to an Asset Purchase Agreement between ASSIGNOR and ASSIGNEE and an Assignment Agreement between ASSIGNOR and ASSIGNEE, both dated January 27, 1995 (collectively referred to as the "Assignment"), ASSIGNOR assigned certain intellectual property it owned to ASSIGNEE;

WHEREAS, although it was the intention of the parties to include the Trademarks in the property transferred by the Assignment, the parties neglected to include the Trademarks in the listing of the intellectual property being transferred in the Assignment; and



PROVIDED, FURTHER that ASSIGNOR hereby agrees and consents to ASSIGNEE filing the appropriate documentation with the United States Patent and Trademark Office and any other United States or foreign governmental agency, division or department, evidencing such assignment and transfer as of January 27, 1995.
