FURTHER, Assignor covenants and agrees that it will, upon the reasonable request of Assignee, execute and deliver, or cause to be executed and delivered, any and all documents and take any and all actions that may be necessary or desirable to perfect the assignments conveyance and transfer of the Trademark hereunder.

This Assignment shall be deemed to be effective as and from the day hereof.
