CONFIRMATION OF PRIOR ASSIGNMENT

In an Agreement dated September 15, 1997, Indian Industries, Inc. a corporation of the State of Indiana located at 817 Maxwell Avenue, P.O. Box 889, Evansville, Indiana 47706-0889, assigned the APEX trademark, including Trademark Registration No. 1,324,748, among others, to the company Impex, Inc., a California corporation located at 14777 Don Julian Road, City of Industry, California 91746. A document confirming this assignment was executed on April 16, 2002 and recorded in the Trademark Office under reel/frame 2527/0380 on June 3, 2002.

Inadvertently, due to a clerical error, Indian Industries listed Trademark Registration No. 1,324,748 in a list of trademark properties which were eventually assigned to SOP Services, Inc. a Nevada corporation located at 2325-B Renaissance Drive, Suite 10, Las Vegas, Nevada 89119. These assignments were recorded at Reels/Frames 2145/0462 and 2207/0065.

Indian Industries, Inc. and SOP Services, Inc. hereby confirm that the APEX trademark, including Registration No. 1,324,748, was assigned to Impex, Inc. on September 15, 1997 and the assignment documents from Indian Industries, Inc. to SOP Services, Inc. erroneously included this trademark registration number.

Indian Industries, Inc. and SOP Services, Inc. hereby acknowledge the assignment and ownership of the APEX trademark to Impex, Inc. on September 15, 1997 and by these presents do contribute, assign, transfer and quit-claim unto Impex, Inc. any and all of their entire right, title and interest in and to the above named trademark, its Certificates of Registrations, together with the goodwill of the business symbolized by said mark, together with all rights of action, in law or in equity, for any past or future infringement thereof.
