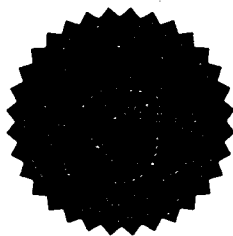

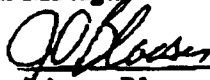
FIFTH. That a copy of the Agreement will be furnished by the Surviving Entity, on request and without cost, to any stockholder of netViz or any member of SA-LLC.
