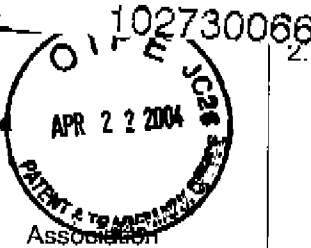

PARTIAL RELEASE OF SECURITY INTEREST

THIS PARTIAL RELEASE OF SECURITY INTEREST made and entered into this 2nd day of April, 2004, by J.P. MORGAN EUROPE LIMITED (formerly Chase Manhattan International Limited) (the "Bank"), as Security Trustee, in favor of AVECIA INC., a Delaware corporation (formerly ZSC Inc.) ("Avecia").

WHEREAS, the Bank, certain of Avecia's affiliates and others are parties to a certain Facilities Agreement dated as of May 12, 1999, as amended pursuant to a supplemental agreement dated June 29, 1999 and a second supplemental agreement dated July 28, 1999 (the "Facilities Agreement"), under which the Bank and other banks parties thereto extended loans to Avecia's affiliates;

WHEREAS, in connection with the Facilities Agreement, the Bank, Avecia and others are parties to a certain Guarantee and Collateral Agreement dated as of June 30, 1999, recorded in the United States Patent and Trademark Office ("PTO") at Reel 10263, Frame 0879, as supplemented by a certain Security Interest In Intellectual Property Rights agreement, dated as of May 10, 2001, recorded in the PTO at Reel 012253, Frame 0489 (together, the "Security Agreement"), under which Avecia granted the Bank, in its capacity as Security Trustee, a security interest in certain patents; and

WHEREAS, Avecia has, pursuant to the Sale and Purchase Agreement dated March 4, 2004 (the "Sale and Purchase Agreement"), by and between Avecia Investments Limited, Avecia Holdings B.V., Avecia UK Holdings Limited, Avecia Inc., Avecia KK, Avecia Limited, Avecia (SCDR) SARL, Avecia GmbH, Avecia Spain SL, Avecia Asia Pacific Pte Limited, Avecia Comercial e Importada Limitada and DTBA Limited and Arch Chemicals, Inc. (the "Purchaser"), and with the consent of the Bank, transferred, among other things, ownership of certain Business Intellectual Property (as defined in the Sale and Purchase Agreement) to the Purchaser.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Bank hereby releases to Avecia all interest which the Bank possesses or is otherwise entitled to in the patents and trademarks listed in Schedule I hereto and (i) all registrations, applications, recordings and common law rights relating thereto; (ii) all renewals thereof; (iii) all income, license royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past, present and or future infringements thereof; (iv) the right to sue for past, present and future infringements thereof; and (v) all rights corresponding throughout the world, it being understood that the security interest is being maintained in the remaining patents and trademarks covered under the Security Agreement.
