RELEASE OF SECURITY INTEREST – TRADEMARK

WHEREAS, Aromatic Technologies, Inc. (formerly known as Aromatic Holdings, Inc.) 

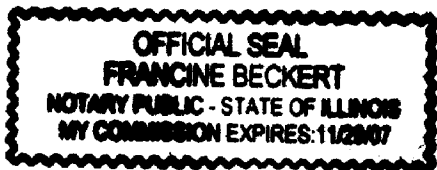
