THIS RELEASE (the "**Release**") is made as of March 9, 2004

BY:

- (1) **THE ROYAL BANK OF SCOTLAND PLC** acting in its capacity as facility agent and security trustee for the Secured Parties and Beneficiaries (each as defined below) on the terms and conditions set out in the Security Documents (as defined below) (the "**Security Trustee**");

in favor of

- (2) **CHEM-TREND INC.** a Michigan corporation ("**Chem-Trend**").

WHEREAS

- (A) Pursuant to a Pledge and Security Agreement dated as of September 28, 2001 (the "**Security Agreement**") between the Security Trustee, Chem-Trend Holding Inc. ("**Chem-Trend Holding**"), Foseco Metallurgical Inc. ("**Foseco**"), Chem-Trend, Remet Corporation ("**Remet**"), and the other parties thereto (the "**Additional Parties**", and together with Chem-Trend Holding, Foseco, Chem-Trend and Remet, the "**Companies**"), Chem-Trend collaterally assigned, conveyed, mortgaged, pledged, hypothecated and transferred to the Security Trustee for the benefit of the Secured Parties (as defined in the Security Agreement), and granted to the Security Trustee for the benefit of the Secured Parties a lien on and security interest in, all of its right, title and interest in, to and under the collateral as identified in Schedule 1, Part A to this Release including, among other things, certain specific assets as identified in Schedule 1, Part B to this Release (the "**Chem-Trend Collateral**"), among which certain security interests were perfected, among other things, by means of recordation of the Security Agreement in the U.S. Patent and Trademark Office and/or U.S. Copyright Office, to secure the prompt payment and performance of all Secured Obligations (as defined in the Security Agreement), (for the avoidance of doubt, the Companies each granted a security interest in Collateral (as defined in the Security Agreement) pursuant to the Security Agreement and the Chem-Trend Collateral referred to in this Release is that part of the Collateral that Chem-Trend gave a security interest in under the Security Agreement, not all of the Collateral);
- (B) Pursuant to a Guarantee (the "**Guarantee Agreement**") dated as of September 28, 2001 made by Chem-Trend in favor of the Security Trustee, as security trustee for the Beneficiaries (as defined in the Guarantee Agreement), Chem-Trend guaranteed to the Beneficiaries and their successors and assigns the prompt payment in full when due of all of the Guaranteed Obligations (as defined in the Guarantee Agreement), and agreed as a primary obligation to indemnify each Beneficiary from time to time on demand from and against any loss incurred by it as a result of the Financing Documents (as defined in the Guarantee Agreement) being or becoming void, voidable or unenforceable for any reason whatsoever, whether or not known to such Beneficiary, the amount of such loss being the amount which such Beneficiary would otherwise

have been entitled to recover from the Borrowers (as defined in the Guarantee Agreement) (the "**Guarantee**").

- (C) Chem-Trend have requested the Security Trustee to release the Chem-Trend Collateral from the security interest created by or pursuant to the Security Agreement, to release the Guarantee created by or pursuant to the Guarantee Agreement (the Security Agreement, together with the Guarantee Agreement are collectively referred to herein as the "**Security Documents**"), and to release Chem-Trend from all of its obligations and liabilities under the Security Documents. The Security Trustee has agreed to release and terminate the security interest in the Chem-Trend Collateral granted in the Security Agreement, to release and terminate the Guarantee granted in the Guarantee Agreement and to release Chem-Trend from all of its obligations and liabilities under the Security Documents upon the terms and conditions contained in this Release.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, the Security Trustee and Chem-Trend hereby agree as follows:

1. Terms defined in the Security Documents (including terms defined by reference to other documents) shall have the same meaning in this Release.
2. The Security Trustee, for itself and on behalf of the Secured Parties, hereby irrevocably and unconditionally releases and terminates the security interest in and lien upon any of the assets of Chem-Trend, including, without limitation, the Chem-Trend Collateral granted by or pursuant to the Security Agreement and, for itself and on behalf of the Beneficiaries, hereby releases and terminates the Guarantee granted by or pursuant to the Guarantee Agreement. In addition the Security Trustee for itself and on behalf of the Secured Parties and the Beneficiaries, as applicable, hereby releases Chem-Trend from all of its obligations and liabilities under the Security Documents. Notwithstanding the foregoing, the Security Trustee is not making any representations or giving any warranties with respect to either the assets of Chem-Trend or the Chem-Trend Collateral subject to this Release. The Security Trustee is releasing the Chem-Trend Collateral in the form received, without recourse to the Security Trustee in relation thereto except as provided for in Section 3.
3. The Security Trustee hereby agrees that it will do (at the cost and expense of Chem-Trend) and hereby authorizes Chem-Trend to do all such things and execute all such documents as may reasonably be necessary to give effect to this Release, including, without limitation, the delivery of any pledged certificated shares and pledged notes in the possession of the Security Trustee, and notices of termination of any account control agreements, and/or the filing of UCC-3 termination statements and the filing of this Release with the U.S. Patent and Trademark Office and/or U.S. Copyright Office, to release the Chem-Trend Collateral and the Guarantee.
4. This Release shall not discharge any of the Companies (other than Chem-Trend) from any liabilities to the Security Trustee (whether in its capacity as trustee or otherwise) or any of the other Secured Parties or Beneficiaries remaining outstanding at the date of this Release, under the Security Agreement or any other Financing Document.

5. This Release may be executed in a number of counterparts, and by the different parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all of which shall together constitute one and the same instrument. Delivery of an executed counterpart of a signature page by fax shall be effective as delivery of a manually executed counterpart.
6. **THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.**
7. **CHEM-TREND AND THE SECURITY TRUSTEE HEREBY IRREVOCABLY WAIVE, TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, ANY AND ALL RIGHT TO TRIAL BY JURY IN ANY LEGAL PROCEEDING ARISING OUT OF OR RELATING TO THIS RELEASE OR THE TRANSACTIONS CONTEMPLATED HEREBY.**

12. to the extent not otherwise included, all Proceeds and products of each of the foregoing and all accessions to, substitutions and replacements for, and rents, profits and products of each of the foregoing, and any and all proceeds of any insurance, indemnity, commercial tort claims, warranty or guaranty payable to Chem-Trend from time to time with respect to any of the foregoing.
