TRADEMARK ASSIGNMENT OF SECURITY

WHEREAS, KIDMA Royal, Inc., a corporation formed under the laws of Delaware, located at 379 Campus Drive, Somerset, New Jersey 08875 ("Grantor"), has adopted, used and is using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, pursuant to that certain Loan and Security Agreement dated as of December 30, 1997 by and between Royal Consumer Information Products, Inc. (f/k/a Olivetti Office USA, Inc.) (the "Borrower") and LaSalle Business Credit LLC (as successor in interest to LaSalle Business Credit, Inc.) as agent for Standard Federal Bank National Association (as successor to Michigan National Bank, as successor to Mellon Bank, N.A.) ("Lender") (including all annexes, exhibits and schedules thereto, and as from time to time amended, restated, supplemented or otherwise modified (the "Loan Agreement") the Lender has agreed to make Loans to Borrower;

WHEREAS, Grantor is obligated to Lender pursuant to (i) a certain Guaranty made by Grantor in favor of Lender pursuant to which Grantor guaranteed to Lender the payment and performance of all of the obligations and indebtedness of Borrower under the Loan Agreement and (ii) a certain Security Agreement, dated the date hereof, made by Grantor in favor of Lender (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements"); and

WHEREAS, pursuant to the Agreements, Grantor is granting to Lender a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Grantor does hereby assign unto Lender and grant to Lender a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which assignment and security interest shall secure all the Obligations as defined in the Agreements and in accordance with the terms and provisions thereof.


Grantor expressly acknowledges and affirms that the rights and remedies of Lender with respect to the assignment and security interest granted hereby are more fully set forth in the Agreements.




