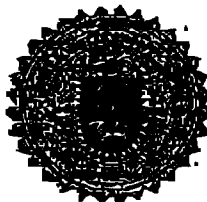

DOES HEREBY CERTIFY:

FIRST: That this corporation was incorporated on the 8th day of April, 1994, pursuant to the General Corporation Law of the State of Delaware, including the provisions of which permit the merger of a subsidiary corporation of another state into a parent corporation organized and existing under the laws of said state.

SECOND: That this corporation owns all of the outstanding shares of the stock of Dade MicroScan Inc., a corporation incorporated on the 23rd day of November, 1994, pursuant to the General Corporation Law of the State of Delaware; and

That this corporation owns all of the outstanding shares of the stock of Syva Diagnostics Holding Company, a corporation incorporated on the 31st day of May, 1985, pursuant to the General Corporation Law of the State of Delaware; and


