RELEASE AND REASSIGNMENT OF TRADEMARK

WHEREAS, K&M Associates, L.P., a Rhode Island limited partnership (the "Company"), owns the registered trademark described in the attached Schedule A (the "Mark"), for which a recording is filed in the United States Patent and Trademark Office under the number set forth in the attached Schedule A; and

WHEREAS, the Company entered into a Credit Agreement dated October 14, 2003 (the "Credit Agreement") between the Company and American Biltrite Inc. (together with the Company being collectively but jointly and severally, the "Borrower"), certain Lenders (as defined therein) and Fleet National Bank (a Bank of America company), both in its capacity as a Lender and in its capacity as administrative agent for the Lenders (the "Agent");


WHEREAS, concurrently with the Credit Agreement, the parties to such agreement also entered into a Security Agreement dated as of October 14, 2003 (the "Agreement");

WHEREAS, pursuant to that certain Agreement, the Company granted a security interest in the Mark to the Agent for a group of lenders, to secure performance by the Company of its obligations to such lenders;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby terminates all of its right, title and interest in, to and under the Mark and reassigns and reconveys to the Company the Mark and all the good will of the business symbolized by the Mark, together with the application, registration and recordings in the United States Patent and Trademark Office, and all reissues, extensions or renewals thereof, together with the right to sue and recover damages for future infringements thereof and to stand in the place of the Agent in all matters related thereto.

The parties hereto have caused this Release and Reassignment of Trademark to be executed this 28th day of October, 2004.
