**ARTICLES OF AMENDMENT OF THE  
ARTICLES OF INCORPORATION OF  
NEW CROSSROADS RV, INC.**

The undersigned officers of New Crossroads RV, Inc. (hereafter referred to as the "Corporation") existing pursuant to the provisions of the Indiana Business Corporation Act as amended (hereafter referred to as the "Act"), desiring to give notice of corporation action effectuating amendment of certain provisions of its Articles of Incorporation, certify the following facts:

**ARTICLE I - AMENDMENT(S)**

**SECTION 1** - The date of incorporation of the Corporation is October 26, 2000.

**SECTION 2** - The name of the Corporation following this amendment to the Articles of Incorporation is: DS Corp.

**SECTION 3** - The exact text of Article I of the Articles of Incorporation is now as follows:

The name of the Corporation is DS Corp.

**SECTION 4** - Date of each amendment's adoption: November 27, 2000
