The undersigned Florida corporation (the "Corporation") hereby submits these Articles of Amendment to the Articles of Incorporation for the purpose of amending its Articles of Incorporation pursuant to Section 607.1006 of the Florida Statutes.

1. The name of the Corporation is "ESSEX PLASTICS, INC."
2. The Articles of Incorporation of the Corporation were initially filed with the Secretary of State of the State of Florida on March 6, 1970.
3. Article I of the Articles of Incorporation, as amended, is hereby amended to read as follows:
