TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of May 19, 2004, by FLEET NATIONAL BANK ("Bank").

WITNESSETH:

WHEREAS, Bank and Byram Healthcare Centers, Inc., a New Jersey corporation ("Grantor"), were parties to that certain Collateral Assignment and Trademark Security Agreement dated as of June 14, 1999 (the "Assignment"), pursuant to which Grantor granted a security interest to Bank in certain trademarks (the "Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Bank, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Assignment Division of the United States Patent and Trademark Office on June 24, 1999, at Reel 1922, Frame 0248; and

WHEREAS, Grantor has requested that Bank release its security interest in the Trademarks and Trademark Rights and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Bank hereby releases its security interest in all of Grantor's right, title and interest in and to:

(i) each Trademark listed on Schedule 1 annexed hereto, together with all rights benefits and privileges derived therefrom, the goodwill of the business symbolized thereby, all registrations thereof, all reissues, divisions, continuations, renewals and extensions thereof, and all proceeds of the foregoing (the "Trademark Rights")

2. Bank hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Bank, all of Bank's right, title and interest in and to the Trademarks and the Trademark Rights.
