Cutting Edge Software, Inc., a Texas corporation (the "Corporation"), pursuant to Articles 4.04 of the Texas Business Corporation Act, hereby adopts the following Articles of Amendment to its Articles of Incorporation and all amendments thereto that are in effect immediately prior hereto:

ARTICLE I

The existing name of the Corporation is "Cutting Edge Software, Inc."

ARTICLE II

Article One of the Corporation's Articles of Incorporation, as amended, shall be amended and restated so that it reads in its entirety as follows:

"The name of the Corporation is Mobility Texas, Inc."

ARTICLE III

The date of the adoption of this amendment by the directors and shareholders of the Corporation was January 5, 2004.

ARTICLE IV

This amendment to the Corporation's Articles of Incorporation have been approved in the manner required by the Texas Business Corporation Act and by the constituent documents of the Corporation, and will become effective when filed by the Secretary of State of Texas.
