ASSIGNMENT OF TRADEMARK

ALL OF THE SAME to be held and enjoyed by said **ENERWISE** for its own use and behoof and for its successors, assigns and legal representatives as fully and entirely as the same would have been held and enjoyed by said had this Assignment not been made.
