CERTIFICATE

Reference is made to the loan and security agreement by and between Fypon, Ltd. (the "*Partnership*") and GE Capital CFE, Inc. (as assignee of Mellon Bank, N.A. ("*Mellon*"), both individually as a lender thereunder and as agent for the other lenders thereunder) ("*GE*") dated June 13, 1997 (the "*Loan Agreement*").

Each of the undersigned, as an authorized person with their respective entities, do hereby certify that to the best of their knowledge, after reasonable investigation, and solely with respect to their respective entity:

- (a) that on or about April 11, 2002, Mellon assigned all of its interest in the Loan Agreement to GE;
- (b) that all of the liens in favor of Mellon as against the assets of the Partnership filed with the U.S. Patent and Trademark Office, the Department of State of the Commonwealth of Pennsylvania, the office of the Prothonotary of York County Pennsylvania and the State Department of Assessments and Taxation of the State of Maryland no longer constitute valid claims and therefore should be released or terminated;
- (c) that on December 20, 2002 all of the obligations of the Partnership under the Loan Agreement were paid and the Loan Agreement was terminated; and
- (d) that as of the date hereof, the Partnership has no current obligations to either Mellon or GE with respect to the Loan Agreement.
