NUNC PRO TUNC TRADEMARK ASSIGNMENT

WHEREAS, Global Crossing Ltd., a corporation duly organized and existing under the laws of Bermuda, and having an address at Wessex House, 45 Reid Street, Hamilton HM12, Bermuda ("Assignor"), pursuant to an assignment from Frontier Corporation executed on September 29, 1999, acquired all right, title and interest in and to the mark uCOMMAND and Design, and United States Registration No. 2,484,230 dated September 4, 2001, for "telecommunications and online services customer account information; telecommunications and online services customer account payment services, consulting telecommunications and online services customers about accounts and account information via a global computer network," together with the goodwill of the business represented and symbolized thereby;
