TRADEMARK ASSIGNMENT

This Trade/Service Mark Assignment ("Assignment") is made on this 5th day of November, 2004, by Nansuco, Inc., a Florida corporation having a principal business address at 1031 Cape Coral Parkway, Cape Coral, Florida 33904 (hereinafter "Assignor"), in favor of Cliff Petrovsky, having a principal business address at 300 E. NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and lets over to Assignee, free and clear from all known claims, liens and encumbrances, its entire right, title, interest in and to the Mark and the registration therefor, and the goodwill of the business associated with the Mark, the same to be held and enjoyed by Assignee, its successors, assigns and other legal representatives. All rights and privileges, including the right to sue for and receive all damages from past infringements of the Mark, will be held and enjoyed by the Assignee, its successors, assigns and other legal representatives. Assignor agrees that it will not seek to register the Mark, or any confusingly similar variation thereof, will not challenge Assignee's rights to the Mark, and will execute such documentation as may be necessary in the future to effectuate this Assignment or any future assignment of the Mark from Assignee to a third party.

This Assignment shall be effective upon Assignee's receipt of the consideration agreed to by the parties hereto.
