The undersigned, a duly authorized officer of Value Music Concepts Inc., a Georgia corporation, the surviving corporation of the merger of Central-South Music Sales, Inc., a Tennessee corporation; Music 4 Less, Inc., a Tennessee corporation; KAR, Inc., a Tennessee corporation; and Record Central, Inc., a Tennessee corporation with and into Value Music Concepts Inc., a Georgia corporation (the "Merger"), pursuant to Section 14-2-1105 of the Georgia Business Corporation Code, as amended hereby certifies as follows:

ARTICLE I

The names of the corporations which are parties to the Merger are "Central-South Music Sales, Inc.," a Tennessee corporation ("CSMS"); "Music 4 Less, Inc.," a Tennessee corporation ("M4L"); "KAR, Inc.," a Tennessee corporation ("KAR"); "Record Central, Inc.," a Tennessee corporation ("RCI," and collectively with CSMS, M4L and KAR, the "Non-Surviving Constituent Corporations") and "Value Music Concepts Inc.," a Georgia corporation ("VMC"). VMC shall be the surviving corporation of the Merger and shall be named "Value Music Concepts Inc." (hereinafter, the "Surviving Corporation").

ARTICLE II

The Articles of Incorporation of the Surviving Corporation shall be the same as the Articles of Incorporation of VMC in effect immediately prior to the Merger, without any amendment thereto.

ARTICLE III

The executed Plan of Merger, dated as of November 21, 2003, adopted by VMC and each of the Non-Surviving Constituent Corporations (the "Plan of Merger"), is on file at the principal place of business of the Surviving Corporation, the address of which is 825-C Franklin Court, Marietta, Georgia 30067.

ARTICLE IV

A copy of the Plan of Merger will be furnished by the Surviving Corporation, on request and without cost, to any shareholder of any corporation that is a party to the Merger.

ARTICLE V

Shareholder approval of the Merger was not required.

ARTICLE VI



ARTICLE VII

The Merger shall be effective as of 11:59 p.m., Atlanta, Georgia time on November 30, 2003.
