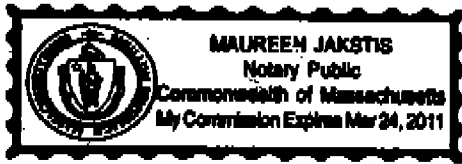
**TRADEMARK ASSIGNMENT
