## SUPPLEMENT NO. 1 TO TRADEMARK SECURITY AGREEMENT

SUPPLEMENT NO. 1 TO TRADEMARK SECURITY AGREEMENT, dated as of October 29, 2004, made by Lacy Distribution, Inc., an Indiana corporation ("Grantor") to the AGREEMENT (TRADEMARK), dated as of February 15, 2001 (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), made by Grantor in favor of Bank of America, N.A., as agent (the "Agent"). All capitalized terms not defined herein shall have the collective meanings ascribed to them in the Credit Agreement described below.

### W I T N E S S E T H:

WHEREAS, pursuant to that certain Amended and Restated Credit Agreement dated as of February 15, 2001 by and among Grantor, the other Persons signatory thereto from time to time as Loan Parties, Agent, and Lenders (including all annexes, exhibits and schedules thereto and as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement"), Lenders have agreed to make the Loans and the Letter of Credit Issuer has agreed to issue Letters of Credit for the benefit of Borrowers;

WHEREAS, Grantor, the other Persons signatory thereto as Grantors (as defined therein) and the Agent are parties to that certain Security Agreement dated as of February 15, 2001 (including all annexes, exhibits or schedules thereto, as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"); and

WHEREAS, the Grantor has acquired the Trademarks set forth on Schedule 1 hereto and desires, pursuant to Section 18 of the Security Agreement, to grant to the Agent, on behalf of the Lenders, a continuing first priority security interest in such Trademarks.

### NOW, THEREFORE, IT IS AGREED:


1. Addition to Schedule of Trademark Security Agreement. The information set forth on Schedule 1 is hereby added to Attachment 1 of the Trademark Security Agreement. Grantor hereby grants to Agent, on behalf of itself and Lenders, a continuing first priority security interest in all of Grantor's right, title and interest in, to and under the Trademarks and Trademark licenses referred to on Schedule 1 hereto, all reissues, continuations or extensions thereof and all products and proceeds thereof, including, without limitation, any claim by Grantor against third parties for past, present or future infringement or dilution of any such Trademark or any such Trademark licensed under any such Trademark license.

2. Counterparts. This supplement may be executed by one or more of the parties hereto on any number of separate counterparts (including by facsimile transmission), and all of said counterparts taken together shall be deemed to constitute one and the same document.

3. Governing Law. This supplement shall be governed by, and construed and interpreted in accordance with, the law of the State of Illinois without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.

IN WITNESS WHEREOF, Grantor has caused this Supplement to Trademark Security Agreement to be executed and delivered by its duly authorized officer as of the date first set forth above.


