INTELLECTUAL PROPERTY ASSIGNMENT OF SECURITY INTEREST

Dated: December 30, 2003

WHEREAS, American Safety Razor Company (the "Grantor") owns all rights, title and interest to the patents listed on Exhibit A ("Patents") and the trademarks listed on Exhibit B ("Trademarks") attached hereto;

WHEREAS, pursuant to that Intellectual Property Security Agreement Supplement, dated May 30, 2002 (as amended, the "Security Agreement"), among Grantor and Bank of America, N.A., as administrative agent for the financial institutions (the "Lenders") from time to time party to that certain Credit Agreement dated as of April 23, 1999 (as amended) among the Grantor, RSA Holdings Corp. of Delaware ("Holdings"), the Lenders, Banc of America Strategic Solutions, Inc. (the "Swing Line Bank") and Bank of America, N.A. (in its capacity as administrative agent for the Lenders, the "Assignor"), the Grantor has granted the Assignor a security interest in the Patents and the Trademarks; and

WHEREAS, pursuant to that certain Omnibus Amendment Agreement dated as of December 30, 2003, by and among Holdings, the Grantor, the Assignor, the Swing Line Bank and Black Diamond Commercial Finance, L.L.C. (the "Assignee"), the Assignor has agreed to assign and transfer to the Assignee all of its rights, interest and privileges to the Patents and the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby sells, assigns and transfers to the Assignee all of the Assignor's right, title and interest granted to Assignor under the Security Agreement in and to the Patents and the Trademarks, together with the goodwill associated therewith, including, without limitation, all rights to sue at law or in equity for any past, present or future infringement thereof, and to receive all proceeds and damages therefrom, to be held and enjoyed by the Assignee, its successors and assigns, as fully as the same would have been held and enjoyed by the Assignor had this assignment and sale not been made.
