FURTHER RESOLVED, that the merger shall become effective as of the close of business on December 31, 1989.

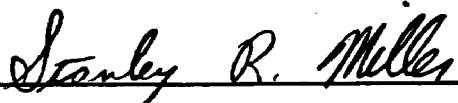
