1. Assignor's right, title and interest in and to the Trademarks and the Tradename together with the goodwill symbolized by the Trademarks and the Tradename, including any available rights to register the Trademarks and Tradename to Assignee throughout the world; and
2. The sole right to enforce rights in said Trademarks and Tradename with the right to sue for and recover for Assignee's own use accrued profits or damages for any and all causes of action, claims and demands and other rights for infringements thereof, including, but not limited to past infringements with respect to which Assignor waives any right to receive any portion thereof.
