RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARKS** (the "Release"), is made effective as of this 5th day of November 2004 by **John Hancock Life Insurance Company ("Assignee") as collateral agent for certain Lenders (defined below)**, in favor of **Houghton Technical Corp. ("Assignor")**.

WHEREAS, pursuant to certain agreements by and among Assignor, Assignee and certain other parties (the "Lenders") (and as they may be further amended, modified or supplemented individually or collectively, the "Loan Agreements"), the Lenders purchased secured notes issued by Assignor;

WHEREAS, in order to secure the complete and timely payment of such notes, Assignor and Assignee entered into a Trademark Security Assignment dated January 18, 2002 (the "Security Assignment");

WHEREAS, pursuant to the Security Assignment, Assignor collaterally assigned, mortgaged, pledged, granted a security interest in, and transferred to Assignee all of Assignor's right, title and interest in and to all of Assignor's intellectual property then owned or existing or filed and thereafter acquired or arising or filed (the "Security Interest");

WHEREAS, the Security Assignment, incorrectly included two United States Trademark Registrations, **Reg. No. 2,167,632 (RECHEM)** and **Reg. No. 751,891 (SLIMEX)**, which registrations had been previously assigned to by Houghton Technical Corp. to Hercules Incorporated in 1998 (the "Pre-assigned Trademarks"), Assignor desires for Assignee to release the Security Interest as to those Pre-assigned Trademarks and agrees to continue to be bound by and comply with all other terms of the Security Assignment as consideration for such release; and,


WHEREAS, Assignor is willing to release the Pre-assigned Trademarks from the Security Interest subject to Assignor's continuing to be bound by and comply with all other terms of the Security Assignment;

NOW, THEREFORE, in consideration of the foregoing premises, Assignee hereby releases the Pre-assigned Trademarks from the Security Interest.
