## Assignment and Acceptance

The Assignor hereby sells and assigns to the Assignee, and the Assignee hereby purchases from the Assignor and assumes all the Assignor's rights and obligations under the Collateral Assignment as of the Effective Date (as defined below) including all right, title and interest in and to the Trademark Collateral (including the trademarks listed on Exhibit A and the goodwill associated therewith) acquired under the Collateral Assignment.

2. The Assignee and Assignor agree that the liability of each of them under this Assignment and Acceptance and any other agreement, document, certificate or instrument delivered by either, or under any law applicable to the Collateral Assignment or the assignment thereof, shall be limited as provided in the Asset Purchase Agreement entered into as of November 15, 2001 between Assignor and Assignee.

3. The effective date of this Assignment and Acceptance shall be July 15, 2003 (the "Effective Date").


4. This Assignment and Acceptance shall be governed by and construed in accordance with the law of the State of New York.

5. This Assignment and Acceptance may be executed in any number of counterparts, each of which shall be deemed an original and which together shall constitute one instrument.




