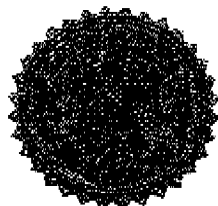

**THIRD:** That the foregoing Amendment to the Certificate of Incorporation shall become effective as of September 30, 2004.


