



**RELEASE FROM
TRADEMARK SECURITY INTEREST**

WHEREAS, pursuant to that certain Revolving Credit and Term Loan Agreement dated as of April 21, 1988, by and among **STERLING SOFTWARE, INC.**, a Delaware corporation (the "*Grantor*"), **FLEET NATIONAL BANK**, a Bank of America company, successor in interest to First National Bank of Boston, a national banking association, with executive offices at 100 Federal Street, Boston, Massachusetts 02110 (the "*Collateral Agent*"), and those banking institutions signatory thereto (the "*Banks*"), as amended by that certain Second Amended and Restated Revolving Credit and Term Loan Agreement dated as of June 8, 1990, the Grantor and Collateral Agent entered into (a) that certain Assignment Agreement dated as of April 20, 1988, as amended by that certain Amended and Restated Assignment Agreement dated as of June 8, 1990, (b) that certain Amended and Restated Notice of Security Interest in Trademarks dated as of June 8, 1990 and recorded with the United States Patent and Trademark Office on June 13, 1990 at Trademark Reel 0716 frames 026 through 030, and (c) that certain Supplemental Grant and Notice of Security Interest in trademarks dated as of November 22, 1993 and recorded with the United States Patent and Trademark Office on November 30, 1993 at Trademark Reel 1069 frame 0429, pursuant to which the Grantor granted to the Collateral Agent, for the benefit of the Banks, a security interest (the "*Security Interest*") in all U.S. Trademarks and associated goodwill therein, and in all other Trademarks and associated goodwill therein then or after-acquired by the Grantor.

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent does hereby terminate and release its interest in and to the Security Interest entered into with the Grantor, and does hereby release any interest it may have, if any, in the trademarks specifically listed on the attached Exhibit A.
