

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
INTERRATRADE INTERNATIONAL, INC.

I.

The name of the corporation is INTERRATRADE INTERNATIONAL, INC.

II.

Effective February 23, 2000, Article I of the Articles of Incorporation of INTERRATRADE INTERNATIONAL, INC. is amended to read as follows:

"1. The name of the corporation (hereinafter called the "Corporation") is INTERRA INTERNATIONAL, INC."


All other provisions of the Articles of Incorporation shall remain in full force and effect.

III.

This amendment was duly approved by the Board of Directors of the Corporation without shareholder approval in accordance with the provisions of Section 14-2-1002 of the Georgia Business Corporation Code and was adopted on February 23, 2000. Shareholder approval was not required for the adoption of this amendment.
