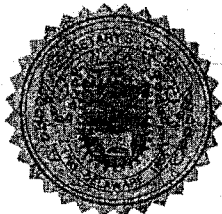

Navigation Technologies Corporation, a Delaware corporation, does hereby certify as follows:

FIRST: That the Amended and Restated Certificate of Incorporation of Navigation Technologies Corporation is hereby amended so that article First shall be deleted as it now exists and the following new article First shall read:
