NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, sells, conveys and transfers to Assignee all of Assignor's right, title, and interest in and to the Marks, together with that part of the good will of the business connected with the use of and symbolized by the Marks, the registrations and applications for registration of the Marks, and the right to sue and collect damages for past infringement of the Marks. Assignor agrees that Assignee may record this Assignment with the United States Patent and Trademark Office or any other applicable governmental office.



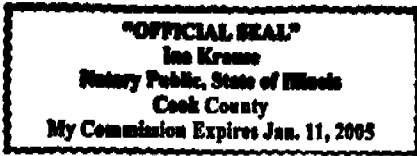
