**NUNC PRO TUNC ASSIGNMENT OF MARK**

This NUNC PRO TUNC ASSIGNMENT OF MARK (this "Assignment") is made effective as of December 23, 1999 (the "Effective Date").

This Assignment shall pertain not only to the above referenced trademark application and resulting registration but also to any common law rights to the Mark and any and all goodwill associated with it.

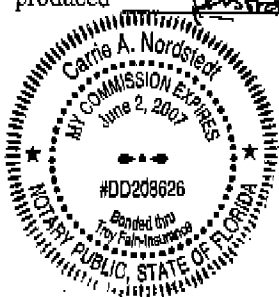
