- B The Parties have agreed that the Trademarks should be transferred by the Assignor to the Assignee on the terms herein.

NOW THIS ASSIGNMENT WITNESSETH as follows:

- 1) In pursuance of this Agreement and in consideration of the sum of One Pound Sterling (£1) now paid by the Assignee to the Assignor (the receipt of which is hereby acknowledged) the Assignor as proprietor hereby assigns to the Assignee all rights, title and interest in and to the Trademarks TOGETHER WITH all rights, powers and privileges belonging to or accrued thereto TO HOLD the same unto the Assignee absolutely.
- 2) The Assignor shall at the expense of the Assignee execute all such documents as the Assignee may reasonably require to properly vest the Trademarks in the Assignee.
- 3) This Assignment shall be interpreted according to the laws of England and the Parties hereto shall subject themselves to the English Courts.


