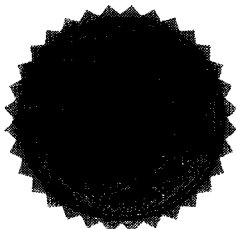

**THIRD:** The name of the surviving limited liability company is Pilgrim Acquisition Company LLC.

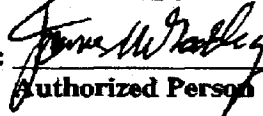
**FOURTH:** The merger is to become effective upon filing on July 31, 2001.
