**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of May 5, 2004 (the "Effective Date"), by Credit Suisse First Boston, a Swiss bank organized and existing under the laws of Switzerland with a business office at Eleven Madison Avenue, New York, New York 10010 as Administrative Agent ("Grantee") for the Lenders (as referred to in the Credit and Guarantee Agreement dated as of December 19, 1997, as amended by the Amended and Restated Credit and Guarantee Agreement, dated as of September 29, 2000 (as amended, supplemented or otherwise modified from time to time)) in favor of Exide Technologies, a Delaware corporation located at 210 Carnegie Center, Suite 500, Princeton, NJ 08540 ("Grantor");

WHEREAS, Grantor has entered into a Collateral Agreement dated as of December 19, 1997, as amended by the Amended and Restated Collateral Agreement, dated as of September 29, 2000 (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement") pursuant to which Grantor has conveyed to Grantee a security interest in, and mortgage on, all right, title and interest of Grantor in and to (i) the patents and patent applications set forth on Schedule A hereto (the "Patents"), (ii) the trademark registrations listed on Schedule A hereto and any common law rights relating thereto, together with the goodwill of the business symbolized by such trademarks (the "Trademarks"), and (iii) all proceeds of the Patents and Trademarks, including, without limitation, any and all causes of action which may exist by reason of infringement or other impairment thereof (collectively the "IP Collateral"), to secure the payment, performance and observance of certain Obligations (as defined in the Collateral Agreement);

WHEREAS, the Grantor has entered into (i) that certain Patent Security Agreement, dated as of January 29, 1998 (the "Patent Security Agreement") (ii) that certain Trademark Security Agreement, dated as of January 29, 1998 (the "Trademark Security Agreement"), (iii) that certain Amended and Restated Patent Security Agreement, dated as of September 29, 2000 (the "Amended Patent Security Agreement"), and (iv) that certain Amended and Restated Trademark Security Agreement, September 29, 2000 (the "Amended Trademark Security Agreement"), and collectively the "IP Security Agreements"), in each case, with the Grantee in order to convey to Grantee a security interest in, and mortgage, on certain IP Collateral;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on Reel 9138, Frame 0621, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on Reel 1722, Frame 0204, the Amended Patent Security Agreement was recorded with the United States Patent and Trademark Office on Reel 11204, Frame 0600, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on Reel 2173, Frame 0023;



WHEREAS, the Grantee agrees to formally release and reconvey to the Grantor the security interest in all of Grantor's right, title and interest in and to IP Collateral subject to the IP Security Agreements pursuant to the terms and conditions set forth in this Release.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Grantee hereby releases and reconveys to the Grantor, without covenant or warranty, express or implied, of any kind and without recourse to it, all of the Grantor's security interest that was granted to the Grantee pursuant to the IP Security Agreements in all of Grantor's right, title and interest in and to the IP Collateral, including the Patents and Trademarks identified on Schedule A hereto.


2. The Grantee acknowledges and affirms that all of the rights and remedies of the Grantee concerning the IP Collateral pursuant to the IP Security Agreements are hereby terminated.


3. The Grantee hereby agrees to execute and deliver to the Grantor, at the sole expense of Grantor, such documents as Grantor shall reasonably request as evidence of the release of security interest pursuant to this Release.

4. The foregoing releases and terminations shall be conditioned upon the occurrence of the Effective Date, as such term is defined in the Grantor's chapter 11 Plan of Reorganization.
