

COLLATERAL ASSIGNMENT FOR SECURITY**(Trademarks)**

WHEREAS, Pet Valu Canada Inc., a corporation organized under the laws of the Province of Ontario (herein referred to as the "**Corporation**"), has adopted, used and is using the trademarks listed on the annexed Schedule 1, which trademarks are registered in, or are the subject of pending applications for registration in, the United States Patent and Trademark Office or the Canadian Intellectual Property Office, as the case may be (collectively, the "**Trademarks**");

AND WHEREAS, the Corporation, Bank of Montreal and Harris Trust and Savings Bank (Bank of Montreal and Harris Trust and Savings Bank are collectively referred to herein as the "**Holder**") are parties to that certain debenture in the principal amount of Cdn.\$25,000,000 dated November 11, 2000 (as the same may be amended, modified or supplemented from time to time in accordance with its terms, the "**Debenture**") which secures the payment of the principal and interest and all other liability from time to time under the Debenture;

AND WHEREAS, pursuant to the Debenture, the Corporation has granted to the Holder a security interest in all right, title and interest of the Corporation in and to the Trademarks, together with the goodwill of the business symbolized thereby and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (collectively, the "**Collateral**"), to secure the payment of the principal and interest and all other liability from time to time under the Debenture;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Corporation does hereby grant to the Holder a security interest in the Collateral to secure the payment of the principal and interest and all other liability from time to time under the Debenture.

The Corporation does hereby further acknowledge and affirm that the rights and remedies of the Holder with respect to the security interest in the Collateral made and granted hereby are more fully set forth in the Debenture, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
