RELEASE OF SECURITY INTEREST

This Release of Security Interest (the "Release") is entered into this 2nd day of December, 2004, by and between *Truebro, Inc.* ("Truebro"), and *Brocar Products, Inc.* ("Brocar").

WITNESSETH:

WHEREAS, Truebro and Brocar entered into a Security Agreement dated September 8, 1999 ("Security Agreement"), which was recorded in the United States Patent and Trademark Office on November 8, 1999, Patent Reel 010360, Frame 0824, and Trademark Reel 001987, Frame 0335, a copy of which is attached hereto as Exhibit A and which is incorporated herein by reference;

WHEREAS, pursuant to the Security Agreement, Truebro granted a security interest to Brocar in certain patents, patent applications, trademarks, trademark applications, and license agreements of Truebro, including the patents listed on Exhibit B and the trademarks listed on Exhibit C, both attached hereto, and the goodwill associated therewith (collectively the "Intellectual Property");


WHEREAS, Truebro and Brocar acknowledge and agree that the obligations and undertakings of Truebro to Brocar that were secured by the Security Agreement have now been performed and satisfied in all respects; and

WHEREAS, Truebro and Brocar accordingly desire to execute, confirm and record a release by Brocar of its security interest in the Intellectual Property, releasing any and all right, title and interest Brocar may have held or presently holds as a result of the Security Agreement, in and to the Intellectual Property identified in the Security Agreement.

NOW, THEREFORE, Brocar hereby and forever releases any and all security interest in and to the Intellectual Property identified in the Security Agreement in favor of Truebro, and assigns to Truebro any and all right, title and interest Brocar may have acquired in and to the Intellectual Property by virtue of the Security Agreement. Further, Truebro and Brocar agree and confirm that this Release may be duly recorded in the United States Patent and Trademark Office so that it can be indexed against any and all of the Intellectual Property.

IN WITNESS WHEREOF, Brocar has caused this Release to be executed and delivered by its duly authorized officer as of the date first above written.
