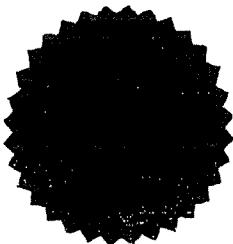

RESTATED CERTIFICATE OF INCORPORATION

**(Pursuant to Section 242)**

**ProtoStor, Inc.**, a corporation (the "**Company**") organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "**DGCL**"), does hereby certify as follows for the purpose of amending its Restated Certificate of Incorporation:

1. That the Company's Restated Certificate of Incorporation is hereby amended as provided herein. Article 1 shall be deleted in its entirety and replaced with the following:

**I**

The name of this company is ProStor Systems, Inc. (the "**Company**").

2. Except as expressly amended by this Certificate of Amendment, the provisions of the Restated Certificate of Incorporation shall remain in full force and effect.

3. That the board of directors of the Company duly adopted resolutions containing provisions of this Certificate of Amendment, declaring such amendment to be advisable and called for the approval of the stockholders of the Company to such amendment in accordance with Section 242 of the DGCL.

4. That the holders of a majority of (i) the issued and outstanding shares of Common Stock of the Company, and (ii) the issued and outstanding shares of Series A Preferred Stock of the Company, acting by means of a written consent in lieu of a meeting pursuant to Section 228(a) of the DGCL, adopted and approved this Certificate of Amendment in accordance with Section 242 of the DGCL.
