Assignor agrees, as long as it exists, to execute all papers necessary in connection with any interference which may be declared concerning said Trademark Properties (and/or registrations that may be granted therefrom), and to cooperate with Assignee in every way possible in obtaining evidence and going forward with such interference.


Assignor covenants that it has full right to convey the interest herein assigned and that it has not executed and will not execute any agreement in conflict herewith.
