

**DEED OF ASSIGNMENT**

**THIS DEED OF ASSIGNMENT** is made as of September 27, 2004 (the "Effective Date").

**BETWEEN**

**TEPMA LYCOS INTANGIBLES, S.A.**, a Spanish corporation with a business address at Via de las Dos Castillas 33, Edificio Ática 1, 28224 Pozuelo de Alarcón, Madrid, Spain (hereinafter referred to as the "Assignor").

**AND**

**LYCOS, INC.**, a Virginia Corporation with a business address at 100 Fifth Avenue Waltham, MA 02451 USA (hereinafter referred to as the "Assignee").

**WHEREAS**, the Assignor is the owner in several jurisdictions of certain (i) trade and service marks in respect of **GAMESVILLE** (design), **GAMESVILLE** (word), **GAMESVILLE.COM** (word) and **MATCHMAKER** (word), and (ii) domain names containing the marks **GAMESVILLE**, **HOTBOT** and **LYCOS**; all the foregoing trade and service marks together with the domain names (hereinafter referred to as the "Marks").

the Assignor hereby sells, assigns and transfers to the Assignee all of its right, title and interest in and to all Marks in all jurisdictions throughout the world, including, without limitation, those set forth on Schedule 1 together with the goodwill of the business symbolized by such Marks, and the registrations and applications thereof and all rights of action, powers and benefits to the same belonging or accrued, which from the date hereof shall be held by the Assignee.

To the extent required by any applicable laws, trademark registration office or domain name registration agent, or as may be requested by Assignee, Assignor shall cooperate, execute all instruments and work together in good faith with Assignee, at Assignor's expense, in order to cause all registrations and applications of Marks to be listed in each appropriate registry under Assignee's name as soon as reasonably possible hereafter.
